

CORPORATION OF THE TOWN OF RENFREW  
BY-LAW NO. 13-2017

Being a by-law to authorize the Mayor and Clerk to execute an Agreement with Beaumen Waste Management Inc. for the provision of recycling collection and processing services.

WHEREAS Section 11 of the Municipal Act, 2001, empowers the Corporation of the Town of Renfrew to pass by-laws and to enter into agreements respecting matters within the waste management sphere of jurisdiction; and

WHEREAS the Council of the Corporation of the Town of Renfrew deems it advisable and in the public interest to enter into an Agreement with Beaumen Waste Management Inc. for the provision of recycling collection and processing services.


NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts as follows:

- 1) THAT the Council of the Corporation of the Town of Renfrew approve of the awarding of the tender from Beaumen Waste Management Inc. for the provision of recycling collection and processing services.
- 2) THAT the Mayor and Clerk be and are hereby authorized, on behalf of the Corporation of the Town of Renfrew, to execute an agreement with Beaumen Waste Management Inc. for the provision of recycling collection and processing services for a five (5) year term commencing June 1, 2017, annexed hereto as "Section 9.0 – Form of Agreement – Recycling" and forming part of this By-Law
- 3) THAT this By-Law shall come into force and take effect immediately upon the passage thereof.

Read a first and second time this 25<sup>th</sup> day of April, 2017.

Read a third and final time this 25<sup>th</sup> day of April, 2017.
