

CORPORATION OF THE TOWN OF RENFREW  
BY-LAW NO. 2-2016

Being a By-Law to authorize the Mayor and Clerk to execute an agreement with the Township of McNab/Braeside respecting the provision of recreation services for the period from January 1, 2016 to December 31, 2016.

WHEREAS Section 11 of the *Municipal Act, 2001*, empowers the Corporation of the Town of Renfrew to pass by-laws and to enter into agreements respecting matters within the culture, parks, recreation and heritage sphere of jurisdiction; and

WHEREAS Section 391 of the *Municipal Act, 2001*, enables a municipality to pass by-laws imposing fees or charges on any class of persons; and

WHEREAS The Council of the Corporation of the Town of Renfrew is the owner of various recreational facilities and parks located within the municipality; and

WHEREAS the Township of McNab/Braeside is desirous to enter into an agreement with the Town of Renfrew respecting the use of and access to recreation programs and facilities offered by the Town of Renfrew.

NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts the as follows:

1. THAT the Agreement attached hereto as Schedule "A" and made part of this By-Law shall constitute a contract between the Corporation of the Town of Renfrew and the Corporation of the Township of McNab/Braeside.
2. THAT the Mayor and Clerk are hereby empowered to do and execute all things, papers and documents necessary to the execution of this by-law.
3. THAT this By-Law shall come into force and take effect immediately upon the passage thereof.

Read a first and second time this 12<sup>th</sup> day of January, 2016.

Read a third time and finally passed this 12<sup>th</sup> day of January, 2016.

**AGREEMENT**

Made this 12<sup>th</sup> day of January, 2016  
BETWEEN

The Corporation of the Township of McNab/Braeside

**AND**

The Corporation of the Town of Renfrew

**WHEREAS** the Town of Renfrew and the Township of McNab/Braeside wish to enter into a shared services agreement for the provision of recreational programs and services;

**AND WHEREAS** the Township of McNab/Braeside wishes its residents to have access to the programs and facilities of the Town of Renfrew;

**AND WHEREAS** the Town of Renfrew is prepared to grant such permission to the residents of the Township McNab/Braeside;

**THEREFORE** the parties hereto agree as follows:

1. Residents of the Township of McNab/Braeside shall be permitted to participate in activities and programs and to use all the facilities operated by the Town of Renfrew Parks and Recreation Department in the same manner and on the same conditions as residents of the Town of Renfrew.
2. On a quarterly basis the Town of Renfrew shall provide a summary of the recreation programs and services offered.
3. It is agreed that the Township of McNab/Braeside will pay the Town of Renfrew the annual fee of \$8,000 plus HST.

The Town of Renfrew shall submit an invoice to the Township of McNab/Braeside in June, with payment due upon receipt.

4. This agreement shall be for a period of one (1) year commencing January 1, 2016 with the option to extend should both parties agree.
5. Either party may terminate this agreement at the end of the agreement upon the giving of sixty (60) days' notice in writing to the other party at its Municipal Office.
6. This agreement may be amended by the parties to the agreement, by mutual agreement at any time after commencement.


