

CORPORATION OF THE TOWN OF RENFREW
BY-LAW NO. 6-2018

Being a by-law to amend By-Law No. 29-2012,
being a by-law to regulate and control parking of
vehicles in the Town of Renfrew.

WHEREAS Section 8 of the Municipal Act authorizes municipalities to govern their affairs and to enact by-laws regulating or prohibiting matters such as parking; and

WHEREAS the Council of the Corporation of the Town of Renfrew deems it expedient to regulate and control traffic and parking of vehicles in the Town of Renfrew; and

WHEREAS Renfrew Town Council is desirous to amend By-Law No. 29-2018 for the purpose of effecting changes governing the parking in Municipal Parking Lots.

NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts as follows:


- 1) **THAT** Part II – Parking, Section 9 – Restricted Parking, sub-sections (1) and (2), be amended to read as follows:
 - (1) Those Municipal Parking Lots, excepting designated Reserved Parking Spaces, highways or portions of highways named and described in **Schedule C** hereto attached shall be designated as “**Restricted Parking**” areas.
 - (2) Where authorized signs to that effect are on display, no person shall park a vehicle within Municipal Parking Lots, excepting designated Reserved Parking Spaces, highways or portions of highways named or described in Schedule C for a period longer than specified, during the time period for which such parking restrictions are in effect as indicated on the said Schedule.
- 2) **THAT** Part II – Parking, Section 13 – Municipal Parking Lots, sub-section (1), be amended to read as follows:
 - (1) No person shall park a vehicle or permit a vehicle to remain parked in the Municipal Parking Lots known as 1. Plaunt Street Lot, 2. Town Hall Lot, 3. Argyle West Street Lot, and Argyle East Street Lot in a designated Reserved Parking Space.
- 3) **THAT** Schedule “C” Restricted Parking, be replaced by the revised Schedule “C” Restricted Parking attached.
- 4) **THAT** this By-Law shall come into force and take effect immediately upon the passage thereof.

Read a first and second time this 23rd day of January, 2018.

Read a third and final time this 23rd day of January, 2018.
