

CORPORATION OF THE TOWN OF RENFREW  
BY-LAW NO. 61-2020

Being a By-law to amend By-law No. 46-2010, being a By-law to regulate the use of lands and the character, location and use of buildings and structures within the Town of Renfrew pursuant to Section 34 of the Planning Act, with respect to the property known municipally as 436 Lisgar Avenue, Town of Renfrew, County of Renfrew, having Roll No. 4748-000-070-17600.

WHEREAS under subsection 34(1) of the Planning Act, zoning by-laws may be passed by the councils of local municipalities; and

WHEREAS By-law No. 46-2010 regulates the use of lands and the character, location and use of buildings and structures within the Town of Renfrew pursuant to Section 34 of the Planning Act; and

WHEREAS an the Town has initiated a zoning by-law amendment with respect to of a certain parcel of land in the Town of Renfrew; and


WHEREAS the Council of the Corporation of the Town of Renfrew deems it appropriate to amend By-Law No. 46-2010 as hereinafter set forth.


NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts as follows:

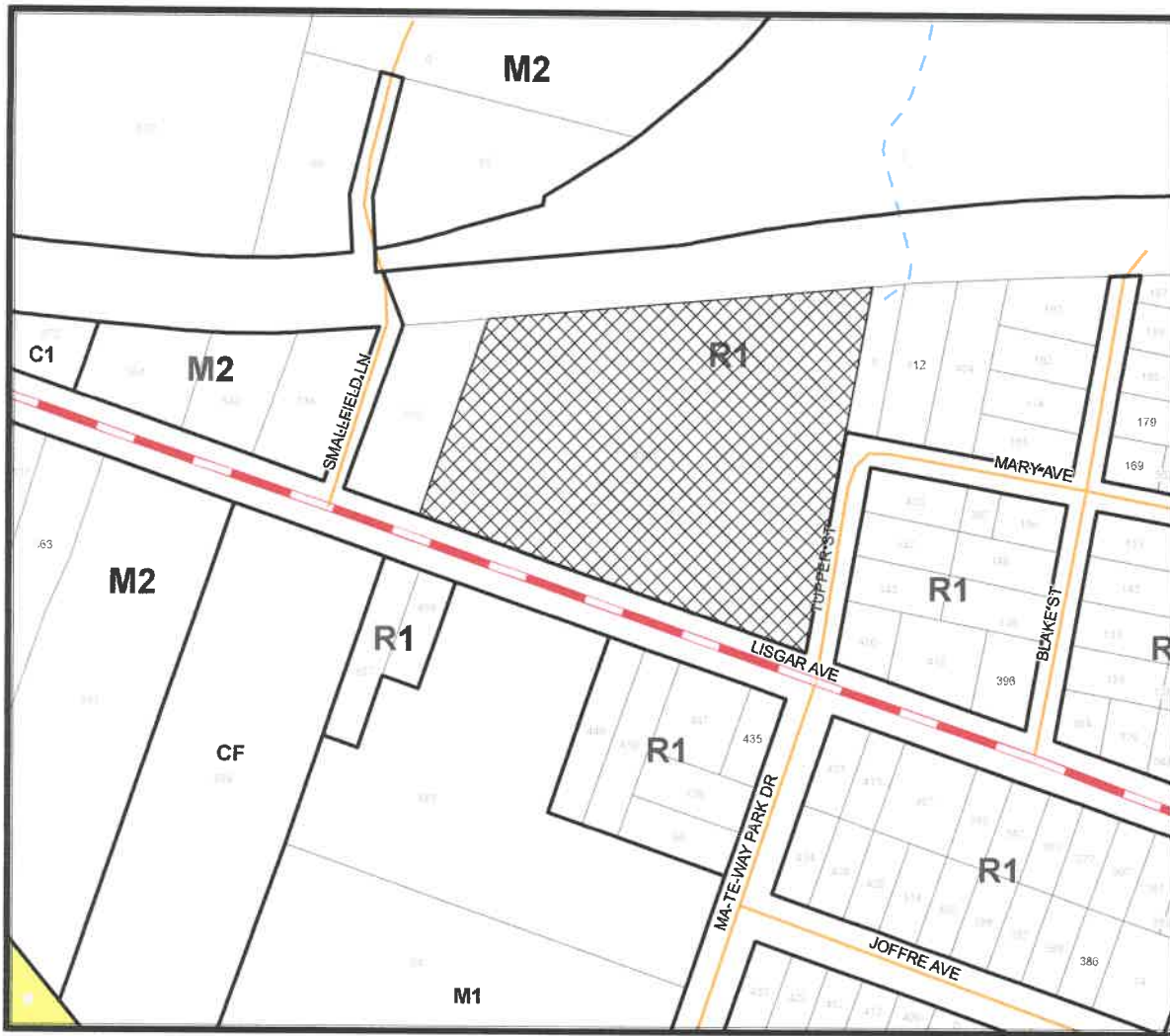
1. THAT the property known municipally as 436 Lisgar Avenue, having Roll No. 4748-000-070-17600, and identified on Schedule "A", attached hereto and forming part of this by-law, shall be the property affected by this by-law.
2. THAT Schedule "A" of Zoning By-Law No. 46-2010 is hereby amended by changing the zoning category from "Residential One (R1) Zone" to "Community Facility (CF) Zone", as identified on Schedule "A" attached hereto and forming part of this by-law.
2. THAT Subject to the giving of notice of passing of this by-law, in accordance with Section 34(18) of the Planning Act, R.S.O. 1990 as amended, this by-law shall come into force on the date of passing by the Council of the Corporation of the Town of Renfrew where no notice of appeal or objection is received, pursuant to Section 34(21) of the Planning Act, R.S.O. 1990 as amended.

Read a third and final time this 8<sup>th</sup> day of September, 2020.
