<u>Public Meeting - Council Structure and Composition:</u> A Public Meeting was held as part of the regular meeting of Council to discuss the Town of Renfrew's Council composition and structure for the upcoming 2026-2030 Term of Council. Two local residents addressed Council and provided feedback.

**Development, Environment & Infrastructure:** Council approved the proposed scope changes to both the *Master Service Plan* and *Official Plan Review*.

**BIA Tax Rate By-Law:** Council adopted the BIA tax rates to support the Downtown Business Improvement Area's expanded \$105,000 budget, up from \$65,000 in 2023, driven by enhanced events and promotions.

**2024 Fees and Charges By-Law:** Based on fulsome discussion at the June 18<sup>th</sup> Committee of the Whole meeting, Council approved the amended changes to the <u>2024 Fees and Charges By-Law</u>. Updated fees will come into effect immediately.

<u>Capital and Operating Budgets:</u> Council received both the Capital Budget (January – March 2024) and the Operating Budget (January – April 2024) Reports. Regular reporting will be done on a rotating bimonthly basis, along with regular summaries to committee of the Whole and further updates to come in August 2024.

Fire, Emergency & Protective Services: Council adopted both the Renfrew Fire Department Regulating By-Law, the Fire Prevention, Inspection and Public Education Policy, and the Fire Investigation Policy.

**Additional staff added to Recreation Operations Team** (Linked to COW discussion): Council approved the hiring of 4 additional full-time staff in the Recreational Operations Department to offset current staff shortages.

Local artwork added to the myFM Centre: As part of the Town's efforts to enhance arts and culture in the community, Renfrew has been fortunate to receive a donation from local artist Patrick John Mills. The piece will be installed and on display at entrance B the myFM centre.

<u>Agreement:</u> The Town entered into a commercial lease agreement and a strategic partnership with the Bonnechere Algonquin First Nation for the use of the Cultural Centre and Medicine Wheel at the myFM Centre.

- Dedicated Gas Tax Funds for Public Transportation Program
- Lease agreements with the use of tenant spaces located at the myFM Centre at 1 Ma-te-Way Drive
