#### **Discussion Item:**

<u>Quarterly Report (Q3)</u> – Departments presented a Q3 review to Council which included progress updates, stats, staff highlights, and more.

#### The Following items were discussed at Committee of the Whole:

**Community Improvement Grant (CIP)** – The Committee of the Whole recommends that Renfrew Town Council approve a \$5,000 CIP grant and financial agreement with Deborah and Samantha Currie for façade, building, and signage improvements at 228 Raglan Street South.

<u>Financial Operating and Capital Budget Report:</u> Council was presented with two reports on Operating Budget to Actual (January to September 2024) and Capital Budget to Actual (January to October 2024). Year to date details were discussed.

**Room Renaming at myFM Centre:** Council discussed the renaming of the "Millar Family Multipurpose Room" at the myFM Centre to the "Second Ice Pad Meeting Room". Recommendation will go forward to Council on December 10<sup>th</sup> for final approval.

Accessibility Audit and Multi-Year Action Plan: The Town Clerk presented findings from the internal Accessibility Audit and the updated 2025-2030 Multi-Year Accessibility Plan.

**Renfrew and Area O.P.P. Detachment Board:** Council directed staff to present a budgetary report on the Renfrew and Area O.P.P. Detachment Board's proposed 2025 budget at the December 10, 2024 Regular Meeting.
